For Candidates belonging to OBC category: The category certificate should be in the prescribed format including the "Non-Creamy layer clause" issued by the Competent Authority for employment under Government of India and should be as per the **Central list of OBC's published by the Govt. of India**. Please also note that the validity of the "Non-Creamy layer should not be older than 6 (six) months from the date of eligibility i.e. 13.05.2019.
